All press-ready PDF and/or images must be a minimum of 300 dpi in black & white/grayscale. We strongly recommends that full page ads with bleeds keep its text, rules, and images that are not intended to bleed, within the page's "live area." This live area equals one-quarter inch inside the trim size on all four sides. Any images or color areas that bleed should be pulled a minimum of one-quarter inch inside the trim size on all four sides.
